AMENDMENT TO THE AMENDED AND RESTATED BYLAWS OF KELLY GREENS VERANDAS IV CONDOMINIUM ASSOCIATION, INC.

Section 3.1 of the Amended and Restated Bylaws of Kelly Greens Verandas IV Condominium Association, Inc. shall be amended as follows. Language to be added is <u>underlined</u> and language to be deleted is <u>struck through</u>. All other provisions shall remain unchanged.

* * * * * * *

3.1 Number and Terms of Service. The number of Directors which shall constitute the whole Board of Directors shall be three (3). Each director shall be entitled to serve for a term of one (1) vear and until his/her successor is duly elected. The Directors shall be elected for two (2) year terms, and the terms of the Directors shall be staggered. A Director's term shall end automatically at the annual meeting at which the Director's successor is duly elected or deemed to have been elected if the number of vacancies equals or exceeds the number of candidates. To establish staggered terms and to maintain a staggered directorate, commencing with the annual meeting and election held in the year 2025, all three (3) seats on the Board will be open for election. The candidate who receives the greatest number of votes shall serve for a two (2) year term. The candidates who are elected with the fewest number of votes shall serve for one (1) year terms. If there is a tie between candidates with the fewest number of votes or if there are only three (3) candidates for the election held at the annual meeting for 2025, then the Directors who will serve one (1) year terms shall be determined by drawing lots. Thereafter, commencing with the annual meeting and election held in the year 2026, when the one-year terms have expired, all Directors shall be elected for two (2) year terms. The intention of this Section 3.1 is to create a system of staggered terms, with an odd number of Directors being elected in every odd-numbered year and an even number of directors being elected in every even-numbered year. Each Director may stand for reelection, unless prohibited by law.
